**PRIVATE PLACEMENT APPROVAL AGAIN EXTENDED**

Toronto, Canada, October 18, 2013 - KWG Resources Inc. (TSX-V: KWG) ("KWG") has been granted a further extension of the conditional listing approval to complete the previously announced private placement of units of flow-through shares and share purchase warrants. The TSX Venture exchange has given the company until November 18, 2013 to complete the balance of the placement of units. A total of \$788,000 has been subscribed to date. Each unit comprises one flow-through treasury share and one warrant which may be exercised to acquire a further flow-through share for \$0.10 at any time within three years. The units may be acquired by qualified investors for a subscription of \$0.05 each.

**About KWG:** KWG has a 30% interest in the *Big Daddy* chromite deposit and the right to earn 80% of the *Black Horse* chromite deposit. KWG also owns 100% of Canada Chrome Corporation which has staked claims and conducted a \$15 million surveying and soil testing program for the engineering and construction of a railroad to the *Ring of Fire* from Exton, Ontario.
